Draft Minutes of the Meeting held at St. Michaels Community Centre at 8pm 14 March 2016

Members Present Chairman Tim Webster, Cllr John Dyer [vice-chair], Cllr Pam Harvey, Cllr David Harrison, Cllr Janice Holmes, Cllr Jimmy Lockhart.

Also in attendance: County Councillor Colin Foulger, District Councillor Phil Hardy, PCSO Darrin Sore, Clerk Gareth Roderick-Jones and 9 members of the public.

Prior to the meeting: PCSO's Report

- There had been a theft of 2 batteries and energisers between 9 and 20 January from Long Lane, and recommended security marking these items which are obviously vulnerable because of the types of location.
- In response to requests from members of the public, the PCSO has recently increased the frequency of foot patrols in the village.
- PCSO Sore will be able to have the use of a traffic speed indicator which shows actual speed and records data. The PCSO will be in attendance whenever the machine is available for use in Flordon.
- PCSO Sore will attempt to get on loan a speed gun for occasional use in Flordon; this will have to be operated by a police constable.

County Councillor's Report

- The contract between Norfolk County Council and BT has been extended with the aim of achieving 95% broadband coverage by the end of 2017. Cllr Foulger will keep us informed of progress.
- From 1 April recycling centres will change to summer hours (see NCC website for details).
- Cycleways in Norwich and area were surfaced using faulty tarmac and these surfaces will have to be replaced. Disruption will include Postwick Junction.

District Councillor's Report:

• District Councillor Hardy is dealing with the Director of the Planning Department in regard to residents' ongoing concerns over the Mushroom Farm, including the amount and timing of heavy traffic, the use of the old entrance, Sunday traffic, and the absence of improvements to drainage which had been promised. The Planning Department have no knowledge of the rumoured withdrawal of the current planning application; the consultation period has been extended and this is expected to go to Committee at the

end of April. Cllr Webster and Cllr Hardy will attend an informal meeting with the Director of the Planning Department (to be arranged).
